#### Call to Order/Approval of Minutes

The meeting was called to order at 7:09 p.m. The December 4, 2017 Board Meeting minutes were discussed. Motion to approve amended minutes was made by Nair and seconded by Diekmann, approved.

#### Treasurer's Report

The treasurer's report was discussed by David Farrell with Treasurer Dick Geil being absent. However, due to the meeting date being so close to year end 2017, checking statements have not yet been received from the credit union for year end reconciling. Approval of current treasurer's report will be tabled until next meeting.

- One invoice was presented by Carroll Marty for work completed in the green space, which was mostly for tree trimming, chipping, and hauling of limbs, totaling \$xxx.xx.

#### Green Space Report

Carroll Marty gave an update on work completed in 2017 for the green space including;

- Tree trimming, chipping, and hauling of debris.
- Planting of eight new trees this fall.
- Cutting down ten trees this year. Currently there are approximately 830 trees in the common areas, 60 of them being Ash trees.
- Great amount of work was completed early in the year on Northridge Parkway and Aspen street areas.

• Future work includes continued work on bike paths, grinding of bumps and ridges, with potential replacement. Also, work needs to be completed on transplanting of hostas.

#### **New Business**

- Bob Steffes announced he will be moving out of Northridge (out of state) in 2018. Bob has kept and maintained the "pin finder" for Northridge for several years. He will deliver to Danny Staedtler for future pin finding requests in Northridge.
- Light discussion of potential "fun run" in Northridge as an association event vs. an ice cream social. 3K run was discussed.
- No applications for fencing or kennels noted.
- Nomination and election of new directors for the 2018 took place as Dick Geil is resigning as treasurer and Jim Bolinger has been inactive this year.
  - No nominations from the floor were presented.
  - There being no further nominations, Carroll Marty made a motion and seconded by Ajay Nair, the directors for 2018 be Farrell, Brinkmeyer, Covert, Diekmann, Nair, Geil, and Gadia, motion carried.
  - The annual meeting was adjourned to accommodate an organizational meeting to follow.
