Ron shared information he collected from Howrey Construction in Bondurant regarding upgrades to walking paths throughout the HOA. Packet included information on concrete vs. asphalt, the process, and the phasing of such a project. Potential project could be broken up into four phases with first phase not to exceed \$400,000.00. Concern for a project of this magnitude and how we would ever accomplish this were discussed. This subject was tabled with potential discussion in the future.
